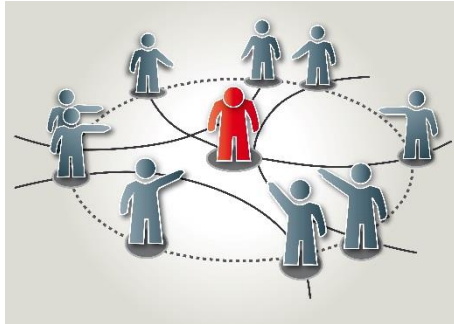


## RESPECT IN THE WORKPLACE FOR MANAGERS AND STAFF
